- Supply and Installation of **02 nos. 60 MVA of 132/33kV Power Transformer.**
- Supply and Installation of **02 nos. 300kVA of 33/0.415 kV Station Transformer, 02 nos. of Earthing Transformer and Standby Generator.**
- Supply & Installation of **02 nos. 33kV Double Circuit Line of 23 Kms.**
- Control Room Building, Security Post, Water supply, Plumbing, Electrical fittings, Internal Access Road, Battery Bank system and other civil works as spelled out in the initial contract, as well as addendum.
