- 3) All the raw materials used in the manufacturing of EHV transformers upto 132 kV Class shall be of the prime grade. Record for the same shall be produced at the time of inspection and EHV transformers shall be manufactured as per best industry standards.
- 4) You shall submit Manufacturing Quality Plan (MQP) for our approval before commencement of manufacturing against any order.
- 5) All required Routine Test, Type tests & Special Test on EHV transformers manufactured as per MSETCL's Technical Specification shall be carried out at NABL Accredited Laboratory in presence of MSETCL's Representative and Third Party Inspection Agency ERDA/ CPRI against supply to MSETCL & the same Test Report should be got approved from this office. MSETCL reserves the right to suggest the names of Laboratories where type tests are to be witnessed by MSETCL's Representative.
- 6) You have to maintain high standards of integrity and performance in respect of their supplies and generally endeavor to give no cause for complaints. The quality of material shall not be compromised at any point of time on any grounds what so ever.

7) Apart from this, MSETCL reserves the right to carry out the complete type/ routine tests on any of the EHV transformers after receipt of adverse feedback from site if any NABL Accredited Laboratory without any extra cost implication to MSETCL. These tests will be carried out at any time during the period of validity of vendor registration.

8) Your representative should be present full time at the site during Erection, Testing & Commissioning of the New Transformer supplied by you without any extra cost

implication to MSETCL.

9) You are bound to provide After Sales Services of the Transformer at site during its guarantee period as and when required without any extra cost implication to MSETCL.

- 10) You shall always maintain the delivery schedule to avoid time over run of projects.
- 11) This vendor approval is for the works address mentioned in this letter and will not apply to any of your branches/offices.
- 12) You are advised to inform us promptly, with necessary supporting documents for any changes in name or ownership or control of the company or address of office, factory partnership deed or any articles of association or your concern telephone number, e-mail address, etc. since your registration, within 30 days of such change and get approval for the same from this office.
